Panels shall be secured along the male rib with approved clips and two corrosion resistant #10-12 A-Point fasteners of sufficient length to penetrate through the sheathing a minimum of  $\frac{3}{16}$ ". The panel clips were placed at a spacing listed in Table A below starting 3" from

panel end. The female rib of panel is snapped over the male rib of panel.




