Two members of the McElroy family are currently active in the business. Tem McElroy serves as Chairman while his son, Ian McElroy, serves as President. Tem and Ian are the son and grandson of McElroy Metal's founder, Thomas E. McElroy, Sr.

#### **Component and Metal Building Manufacturing**

McElroy Metal owns and operates 13 manufacturing locations across the United States. Growth has been achieved through a combination of acquisition and green field development. Monarch Metal Buildings, a McElroy Metal division, manufactures frames for pre-engineered buildings.

#### **Insulated Metal Panel Manufacturing**

Recognizing a growing demand for energy efficient building materials, McElroy Metal entered into a joint venture with Green Span Profiles in 2011 to manufacture Insulated Metal Panels (IMP). Subsequently, in 2012, Green Span Profiles built a state-of-the-art facility in Waller, TX to manufacture IMP's ranging from 2" – 6".

#### **Distribution**

McElroy Metal is active in the distribution of building materials through McElroy Metal Service Center and Metal Mart divisions. Combined, these two entities operate 66 locations across the United States.

#### **Industry Leadership**

McElroy Metal has a history of active involvement with industry trade groups and associations. While active with many organizations, McElroy Metal has current Board of Director representation on the Metal Roofing Alliance and the National Frame Building Association.

#### **Company Culture**

Remaining privately owned, McElroy Metal leadership is able to operate the business without board or outside influence. The core principle of running the business under a moral and ethical code of conduct has remained through three generations of leadership and is practiced daily by the company's 750 employees.

#### **In-House Technical Services**
